Please explain how these funds will be used to provide a public benefit:

Children's Trust of South Carolina is developing a statewide Family Resource Network to convene and collaborate with leaders in the family support and strengthening field throughout South Carolina. Children's Trust is the designated South Carolina member of the National Family Support Network and is maximizing this opportunity to build and strengthen relationships with other states for peer learning and collaborative opportunities to support family resource centers (FRCs). Children's Trust aims to convene a minimum of ten FRCs through the network and offer funding for service provision. Expanding the work of FRCs in South Carolina through the CBCAP and state appropriation funding will allow Children's Trust to collaborate with a variety of partners across the entire sector of family support professionals. Children's Trust perceives the convening of this network and subsequent funding of prevention initiatives through FRCs as a targeted strategy to address overarching goals in the organization's strategic plan. These goals include changing the narrative as advocates for children and systemic change, strengthening prevention networks by working with partners and stakeholders, and leading the agenda of large-scale transformation that benefits children and families. For Child Abuse Prevention month Children's Trust will also use public relations strategies, such as press conferences and pinwheel planting events, to anchor an earned media campaign. We will also use paid media to increase CAP Month material registrations and build general awareness through robust social media and email campaigns.
