Family Resource Centers: Children's Trust of South Carolina is committed to strengthening families and communities to prevent child abuse and neglect through effective, sustainable, and innovative approaches. In July 2021, Children's Trust began convening Family Resource Center (FRC) partners at the state level to foster peer learning, collaborative work, and capacity building for effective service delivery and overall better support for families across the state. As the South Carolina Family Resource Network (SC FRC Network) continues to strengthen, so does its support and services for families. Parent Engagement: Children's Trust is in the process of establishing a statewide Parent Advisory Council that will advise the organization on needs, resources, and opportunities for parents across the state. Thriving Families Safer Children: This initiative, focused on authentic co-creation with individuals with lived experience, is led by a statewide steering committee. The statewide steering committee is made up of more than 50% individuals with lived experience as well as the leaders of state agencies and nonprofit organizations.
