Department of Children's Advocacy Publishes 2021 Annual Report



S.C. Code of Laws Ann. Section 63-11-2270(7) requires that the State Child Advocate submit an annual report to the Governor, President Pro Tempore of the Senate, Speaker of the House of Representatives, and Joint Citizens and Legislative Committee on Children detailing the State Child Advocate's activities.

The 2021 Annual Report includes information about the Cass Elias McCarter Guardian ad Litem Program, Foster Care Review Division, S.C. Continuum of Care, Investigations Unit, Juvenile Court Program, and Legal Extern Program. Suicide Prevention: Hope Lives in SC







At the end of 2021, Dr. Liyun Zhang, Research Scientist with the Children's Law Center, provided an informational briefing regarding the Children's Committee's 2021 Data Reference Book. Suicide rose to the #1 leading cause of death for children ages 10 to 17 in South Carolina. The Department of Children's Advocacy continues to reach out to Foster Care Review Board members and volunteer Guardians ad LItem to assist them with completing the online suicide prevention training which was made available by the Department of Mental Health's Office of Suicide Prevention. All DCA staff completed online suicide prevention training which was made possible through a grant with DMH's OSP and the American Foundation of Suicide Prevention. FY 2022-23 Budget Request Presented at Subcommittee Hearing



Department of Children's Advocacy Director Amanda Whittle testified before the House Ways and Means Healthcare Subcommittee on January 12, 2022 regarding the agency's FY23 budget request. Her testimony included the Department of Children's Advocacy's Annual Accountability Report highlights, efforts to mitigate expenses and maximize funding, and a proviso request summary. The agency is requesting \$800,000 in recurring funding and \$175,000 in non-recurring funding for FY23. Governor Henry McMaster has included these amounts in his proposed budget to the General Assembly. The following is a summary of the Department of Children's Advocacy's FY23 Budget Request:

Funding Type (in order of priority)	Funding Amount	Funding Purpose
Recurring: Investigations Unit Infrastructure	\$200,000	To fully staff the Department of Children's Advocacy's Administration and System Improvement Unit - Projections for DCA's FY22 Administration budget are (33,432) i positions are filled based on current funding.
Recurring: Continuum of Care Transfer Alignment	\$400,000	To offset the elimination of a \$400,000 transfer to Continuum of Care by DMH – DMH has requested that the Proviso 35.1 allocation to Continuum of Care be eliminated. This transfe has been in effect for approximately twenty years.
Non-Recurring: Foster Care Review Advocacy Upgrade	\$150,000	To replace the current database with a case management system that drives action and advocacy for children in foster care -The current system is a legacy system that has become unreliable and inefficient.
Recurring: Foster Care Review Advocacy Upgrade	\$200,000	To support staff capacity and training regarding the reviews of children in foster care - The number of children who are reviewed by FCRB has increased by about 33% since this division's FTEs were allocated.
Non-Recurring: Administration Communications	\$ 25,000	To fulfill the mission of educating the public and improving the child-serving system —to include signage, videography, and training for staff, volunteers, other agencies and the public.
