#### A Message from the State Child Advocate



This edition of The Advocate focuses on building internal capacity within the Dept. of Children's Advocacy as well as building our external system of care's capacity for a robust service and placement array. We are highlighting our ongoing advocacy for a state-operated Residential Treatment Psychiatric Facility (PRTF) for seriously mentally ill, justice-involved youth as well as the Cass Elias McCarter Guardian ad Litem Program's work, under the leadership of GAL Program Director LaDara Josey, to the recruitment, training, supervision, and retention of volunteer who provide best-interests advocacy for abused and neglected children,

It is also my pleasure to introduce Foster Care Review Division Director Lindsey Taylor and Investigations Unit Director Laurie Pineau Davidson, J.D.

#### Congratulations and thank you to Paula Lance on her retirement!



# Advocacy for a State-Operated Psychiatric Residential Treatment Facility

Department of Juvenile Justice (DJJ) Director Eden Hendrick' fanned the flames of mental health advocacy for justice-involved youth when she requested \$20 million during DJJ's House and Senate budget subcommittee hearings during February 2022. Director Hendrick requested non-recurring funding to build a Department of Mental Health (DMH)-operated Psychiatric Residential Treatment Facility (PRTF) for seriously mentally ill, justice-involved youth.

S.C. Code of Laws Ann. Section 63-19-1450 prohibits seriously mentally ill youth and intellectually disabled youth from being committed to a DJJ institution and authorizes DJJ to transfer these youth to the state agency which is best qualified for the care of the child. The two designated state agencies for transfer are DMH for seriously mentally ill youth and Department of Disabilities and Special Needs (DDSN) for intellectually disabled youth.

The last state-operated PRTFs were operated by DMH and closed in 2015. Children and youth who need this level of care are currently placed at private PRTFs, but the array of private PRTFs does not meet our state's placement needs, particularly for justice-involved, seriously mentally ill youth. Due to a lack of appropriate placement, seriously mentally ill youth are not being transferred to an appropriate DMH facility and are continuing to be committed to and confined at DJJ.

This gap in service and placement must be filled by the state in order to place children appropriately and to place them in South Carolina near their homes, communities, and continuum of treatment providers.

## We are recruiting volunteers to advocate for children!

In FY20-21, the Guardian ad Litem Program served a total of 14,392 children. The program was serving an average of 8709 children monthly with 5163 being served by volunteers and 3546 being served by staff. The GAL Program has committed to recruiting 935 additional volunteers to advocate for abused and neglected children.


**Sarah Faye Towe** Program Coordinator I Pickens County Guardian ad Litem Program
